APPROPRIATION ORDINANCE No. 01, SERIES OF 2020

AN ORDINANCE RE-APPROPRIATING THE AMOUNT OF FIVE MILLION, FIVE HUNDRED THIRTY THOUSAND, EIGHT HUNDRED TWO PESOS AND TWENTY EIGHT CENTAVOS (PHP. 5, 530,802.28) TAKEN FROM TWENTY PERCENT (20%) COMMUNITY DEVELOPMENT FUND, CALENDAR YEAR 2020, TO BE UTILIZED FOR THE EMBANKMENT AT G-PARK, MUNICIPALITY OF CAN-AVID, EASTERN SAMAR.

Be it resolved that:

SECTION I - that this Appropriation Ordinance No. 02, Series of 2018 shall be known as "AN ORDINANCE RE-APPROPRIATING THE AMOUNT OF FIVE MILLION, FIVE HUNDRED THIRTY THOUSAND, EIGHT HUNDRED TWO PESOS AND TWENTY EIGHT CENTAVOS (PHP. 5, 530,802.28) TAKEN FROM TWENTY PERCENT (20%) COMMUNITY DEVELOPMENT FUND, CALENDAR YEAR 2020, TO BE UTILIZED FOR THE EMBANKMENT AT G-PARK, MUNICIPALITY OF CAN-AVID, EASTERN SAMAR.

SECTION II – That the above mentioned re-appropriated funds shall be utilized for the purpose it is intended for:

SECTION III - That misappropriation or juggling of funds shall not be allowed;

SECTION IV – Effectivity Clause- that this Appropriation Ordinance shall takes effect immediately upon its approval. So ordained.
