**SECTION I** – this Appropriation Ordinance Shall be known as an ORDINANCE APPROPRIATING THE AMOUNT FROM REPROGRAMMED FUNDS, SUPPOSEDLY INTENDED FOR PROGRAMS, PROJECTS AND ACTIVITIES (PPA's) UNDER SPECIAL PURPOSE APPROPRIATION (SPA), REFLECTED IN THE ANNUAL BUDGET, FISCAL YEAR, 2020, AMOUNTING TO FOUR MILLION ONE HUNDRED TWENTY FOUR THOUSAND, ONE HUNDRED SIXTY SEVEN PESOS AND FORTY SIX CENTAVOS (PHP. 4, 124,167.46) TO FUND THIS IDENTIFIED PROGRAMS, PROJECTS AND ACTIVITIES (PPA's)

**SECTION II** - that said total Reprogrammed Fund, supposedly intended to fund certain PPA's reflected in the Annual Budget, Fiscal Year 2020, shall now be utilized to Fund recent identified Priority Programs, Projects and Activities (PPA's) as above mentioned.

**SECTION III** – that juggling of funds is strictly prohibited under existing COA Rules and Regulations;

**SECTION IV – Effectivity** -This Ordinance as Supplemental Appropriation shall takes effect immediately upon its approval. So ordained.


