APPROPRIATION ORDINANCE No. 11 , SERIES OF 2020

AN ORDINANCE APPROPRIATING FUND AS SUPPLEMENTAL BUDGET, AMOUNTING TO ONE MILLION, SEVENTY SIX THOUSAND, SIX HUNDRED TWENTY PESOS AND SEVENTY FIVE CENTAVOS (PHP.1,076,620.75) REALIZED FROM UNUTILIZED FUND/ SAVINGS, CALENDAR YEAR 2020, TO DEFRAY THE ISSUANCE OR PAYMENT OF SALARY DEFERENTIALS (JANUARY –DECEMBER, 2020), HAZARD PAY, MID YEAR BUNOS,GSIS GOVERNMENT SHARE AND PHILHEALTH GOVERNMENT SHARE, OF ALL MUNICIPAL OFFICIALS AND PERMANENT/REGULAR EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF CAN-AVID, EASTERN SAMAR, IN COMPLIANCE TO THE IMPLEMENTATION OF THE FIRST TRANCHE OF THE MODIFIED SALARY SCHEDULE FOR LOCAL GOVERNMENT PERSONNELS PURSUANT TO REPUBLIC ACT (RA) 11466. ITIMIZED AS FOLLOWS, TO WIT

a.) One (1) year Salary Deferential	Php. 793,308.00
b.) One (1) year Hazard Pay	44,989.80
c.) One (1) year Mid Year	132,218.00
d.) One (1) Year GSIS Government Share	95,196.96
e.) One (1) Year Phil health Government Share	10,907.99
Total:	Php.1, 076,620.75

BE IT RESOLVED that;

SECTION I - that this appropriation Ordinance shall be known as an **"AN ORDINANCE APPROPRIATING FUND AS SUPPLEMENTAL BUDGET, AMOUNTING TO ONE MILLION, SEVENTY SIX THOUSAND, SIX HUNDRED TWENTY PESOS AND SEVENTY FIVE CENTAVOS (PHP.1,076,620.75) REALIZED FROM UNUTILIZED FUND/SAVINGS, CALENDAR YEAR 2020, TO DEFRAY THE ISSUANCE OR PAYMENT OF SALARY DEFERENTIALS (JANUARY – DECEMBER, 2020), HAZARD PAY, MID-YEAR BUNOS, GSIS GOVERNMENT SHARE, PHILHEALTH GOVERNMENT SHARE, OF ALL MUNICIPAL OFFICIALS AND PERMANENT/REGULAR EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF CAN-AVID, EASTERN SAMAR, IN COMPLIANCE TO THE IMPLEMENTATION OF THE FIRST TRANCHE OF THE MODIFIED SALARY SCHEDULE FOR LOCAL GOVERNMENT PERSONNELS PURSUANT TO REPUBLIC ACT (RA) 11466."**

SECTION II - that this is in compliance to the implementation of the Modified Salary Schedule for Civilian Personnel shall be implemented in four (4) tranches from FY 2020 to FY 2013 as provided for under Republic Act (RA) 11466;

SECTION III - that fund appropriated as Supplemental Appropriation shall solely be utilized for the issuance of **Salary Deferential (January – December, 2020), Hazard Pay, Mid-year Bunos, GSIS Government share, Phil health Government Share**, for all Municipal Officials and Permanent employees of the Local Government Unit of Can-avid, Eastern Samar.


SECTION IV – that Juggling of funds is strictly prohibited under existing COA Rules and Regulations.


SECTION V- EFFECTIVITY – this Appropriation Ordinance shall take effect immediately upon its approval. So ordained.


