Municipal Ordinance No. 02, Series of 2020

AN ORDINANCE FIXING THE RENTAL FEE FOR THE USE OF THE EVACUATION CENTERS AS VENUE FOR PRIVATE GATHERINGS, PARTIES AND SEMINARS FOR COMMERCIAL, PROFESSIONAL OR PERSONAL BUSINESS AT THE RATE STATED HEREUNDER, TO WIT:

EVACUATION CENTER Located at Old Public Plaza - - - - - Php. 5,000.00 per day
EVACUATION CENTER Located at Barangay 03, Pob. 3,000.00 per day

BE IT ORDAINED that;

SECTION I – This Municipal Ordinance shall be known as “Ordinance fixing the rental fee for the use of Evacuation Centers as venue for private gatherings, parties, seminars for commercial, professional or personal Business at the rate stated above”

SECTION II – Any person, organization or corporation who will use the Existing Evacuation Centers, Located at Barangay 04, Pob. (Old Plaza) and Barangay 03, Pob., for Private Gatherings, parties, seminars for commercial, professional or personal Business shall pay the required Rental Fee, stated hereunder, to wit:

<i>Evacuation Center, Located at Old Public Plaza</i>	<i>Php. 5,000.00 Per day</i>
<i>Evacuation Center, Located at Barangay 03, Pob.</i>	<i>3,000.00 Per day</i>

SECTION III – whoever interested to use as venue this Evacuation Centers for Private Gatherings or affairs, shall pay the necessary Rental Fee as stated above, with the Municipal Treasurers Office and will be issued the corresponding Official Receipt as Proof of Payment;

SECTION IV - that the Assigned LGU Coordinator shall be responsible to enter the Date of said activities in the Treasurers Log Book to avoid conflict of schedule;

SECTION V – That inclusive of the **Rental is the use of Electricity and other amenities inside the Evacuation Centers**. However, it shall be the responsibility of the Renter to preserve and protect all fixtures inside the Public Building or Structure (Evacuation Center);

SECTION VI – REPEALING CLAUSE – All Ordinances Rules and Regulations or parts thereof in conflict or in consistent with the provisions of the Ordinance are hereby repealed or modified accordingly;


SECTION VII – EFFECTIVITY- This Ordinance shall takes effect immediately upon its approval. So ordained.






