GERMINO TO DEDUCT OR SET-ASIDE CERTAIN AMOUNTS OUT OF THE EXISTING TRAVEL FUND, CALENDAR YEAR 2020, OF DEFERENT OFFICES INCLUDING LEGISLATIVE AND EXECUTIVE, TO AUGMENT FUND AS SAVINGS, FROM APRIL TO JUNE, 2020, AMOUNTING TO TWO MILLION, FOUR HUNDRED THOUSAND, FIVE HUNDRED PESOS AND TWO CENTAVOS (PHP.2, 400,500.02) TO FUND FOR CERTAIN IDENTIFIED PRIORITY PROGRAMS AND PROJECTS THIS MUNICIPALITY, TO WIT:

WHEREAS; Section 447 of RA 7160, Otherwise known as the Local Government Code of 1991, The Sangguniang Bayan as the Legislative Body of the Municipality, shall enact Ordinance, approve Resolutions and appropriate funds for the General Welfare of all constituents in the Municipality;

WHEREAS; while Section 336 of the same Act specifically provides that the Local Chief Executive or the Presiding Officer of the Sangguniang Bayan concerned may, by Ordinance be authorized to augment any item in the approved Annual Budget for their respective offices from the savings in the other items, within the same expense class of their respective Appropriations.

WHEREAS; Chapter 3, Article one, Section 444 (a) (1) par.vi of RA 7160 otherwise known as the Local Government Code of 1991 provides that *“Upon authorization by the Sangguniang Bayan, represents the Municipality in all its transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance”*


