AN ORDINANCE AS ADDENDUM TO ARTICLE B. SECTION 48.01, OF THE UPDATED MUNICIPAL REVENUE CODE OF FEES AND CHARGES, SERIES OF 2017, ON IMPOSITION OF FEES, IN COMPLIANCE TO THE IMPLEMENTATION OF THE PHILIPPINE STATISTIC AUTHORITY (PSA), CIVIL REGISTRY SYSTEM IT (CRS- IT) PROJECT USING THE BREQS –LGU SYSTEM, PROVIDING AN OFF- LINE METHOD OF ENCODING REQUEST FOR CIVIL REGISTRY DOCUMENTS ISSUED BY A SERBILIS OUTLET LIKE THE LOCAL GOVERNMENT UNIT OF CAN-AVID, EASTERN SAMAR.

**EXPLANATORY NOTE:**

The Local Government Unit of Can-avid, Eastern Samar has been identified as recipient of the Civil registry IT (CRS- IT) project, which is the establishment of an on- line census Serbilis Centers (Serbilis Outlets) for purposes of decentralized servicing of requests for Civil Registry documents from the public. And the use of BREQS –LGU System by the Local Government Units will enable to benefit an off-line method of encoding requests for Civil Registry Documents and submission thereof to an on-line Serbilis Outlet of the Philippine Statistic Authority (PSA).

**SECTION I** – This Municipal Ordinance shall be known as “AN ORDINANCE AS ADDENDUM TO ARTICLE B. SECTION 48.01, OF THE UPDATED MUNICIPAL REVENUE CODE OF FEES AND CHARGES, SERIES OF 2017, ON IMPOSITION OF FEES, IN COMPLIANCE TO THE IMPLEMENTATION OF THE PHILIPPINE STATISTIC AUTHORITY (PSA), CIVIL REGISTRY SYSTEM IT (CRS- IT) PROJECT USING THE BREQS –LGU SYSTEM, PROVIDING AN OFF- LINE METHOD OF ENCODING REQUEST FOR CIVIL REGISTRY DOCUMENTS ISSUED BY A SERBILIS OUTLET LIKE THE LOCAL GOVERNMENT UNIT OF CAN-AVID, EASTERN SAMAR.

**SECTION II** – That In addition to the usual fees collected for the civil registry Services, as provided for under Article B. Section 48. Sub-section 01, on Imposition of fees, an amount of Fifty (Php.50.00) Pesos will be collected from client who wants to avail the BREQS- LGU System or as the Serbilis Outlet as mandated by the Philippine Statistic Authority (PSA);

**SECTION III** – that said additional Service fee in the amount as above-mentioned **shall be collected by the Municipal Treasurer or any of the Revenue Collection Officers with the issuance of an Official receipt as proof of payment**, and shall be presented to the Local Civil Registrar Office for the processing of documents.













**SECTION IV – Separability Clause** – if for any reason, any section or provision of this Ordinance shall be unconstitutional or invalid by competent authority, such judgment or action shall not affect or impair the other sections or provisions thereof.

**SECTION V – Effectivity-** This Municipal Ordinance shall takes effect immediately upon its approval or **Ten (10) days** upon Publication with the newspaper of general circulation or within three (3) conspicuous places in the Municipality.


