AN ORDINANCE SPECIFYING THE INTENDED LOCAL PROJECTS (CONCRETING OF BARANGAY STREETS OUTSIDE POBLACION) TO BE FUNDED OUT OF THE SIX MILLION (PHP.6, 000,000.00) PESOS ALLOCATED UNDER THE TWENTY (20%) PERCENT DEVELOPMENT FUND, CALENDAR YEAR 2020, WHILE A SEPARATE ALLOCATION AMOUNTING TO TWO MILLION, FIVE HUNDRED THOUSAND (PHP.2,500,000.00) PESOS, SUPPOSEDLY INTENDED FOR CONTINUATION OF SUB CANAL AT G-PARK AND GALES STREET, INSTEAD TO BE REPROGRAMMED TO DEFRAID THE COST OF CONCRETING OF MAYOR ALEJO STREET, BARANGAY 10, POBLACION, CAN-AVID, EASTERN SAMAR,.

1. Continuation of Sub Canal at G-Park and Gales Street (Reprogrammed to: CONCRETING OF MAYOR ALEJO STREET, Barangay 10, Poblacion, Can-avid, Eastern Samar – Php. 2,500,000.00 Pesos

**SECTION I** – That Fund has been allocated under 20% Development Fund, Calendar Year, 2020, amounting to **Six Million (Php.6,000,000.00) Pesos**, Generally intended for Concreting of Streets outside Poblacion, absence any specifications as to location of Projects and the amount intended for, what appears is the lump sum appropriation; while a Separate Fund allocation, amounting to **Two Million, Five Hundred Thousand (Php.2,500,000.00) Pesos** supposedly for Continuation of Sub Canal at G-Park and Gales Street, was reprogrammed to Concreting of **Mayor Alejo Street, Brgy.10,Pob**, this Municipality;

**SECTION II** – that as provided for under existing COA Rules and Regulations, projects to be funded under the 20% Development Fund, must be specified and clear, specifically on how it is intended for;

**SECTION III** – That to clarify matters as to the purpose why this Lump sum allocation was intended for. the Sangguniang Bayan, come up to specify each of the Local Projects, with the required budgetary Allocation, so not to be considered as splitting of Projects, which is not allowable under existing Rules and Regulations of RA 9184 otherwise known as the Government Procurement Reform Act of 2002;


**SECTION VI – Repealing Clause.** All ordinances issuances, orders, rules ad regulations which are inconsistent with any of the provisions of this Ordinance are hereby deemed repealed and/or modified accordingly..

**SECTION VII – Separability Clause** – If any of the provisions in this Ordinance be declared invalid or unconstitutional. Those which are not so declared shall remain in full force and effect.


**SECTION VIII – Effectivity.** This ordinance shall take effect immediately upon its approval. So Ordained.






