RESOLUTION No.19, SERIES OF 2020

RESOLUTION AUTHORIZING MUNICIPAL TREASURER BRENDA P. GALUPE AS PETTY CASH COSTUDIAN FOR THE MUNICIPALITY OF CAN-AVID, EASTERN SAMAR LIMITED TO ONE HUNDRED THOUSAND (PHP.100,000.00) PESOS ONLY OUT OF THE BUDGETED/ALLOCATED MDRRM TRUST FUND, CALENDAR YEAR 2020, TO BE UTILIZED TO DEFRAY THE COST OF FOOD SUSTAINANCE/ CONSUMPTION OF ALL FRONTLINERS WHO WERE ASSIGNED TO PREVENT THE SPREAD OF CORONA VIRUS (COVID-19) TO THE MUNICIPALITY OF CAN-AVID, EASTERN SAMAR WHILE GENERAL COMMUNITY QUARANTINE (GCQ) WAS DECLARED INCLUDING THE ENTIRE PROVINCE OF EASTERN SAMAR.

WHEREAS; as provided for under the issued Provincial Executive Order from the Office of the Governor the entire Province of Eastern Samar was on a modified Community Quarantine (MCQ), with a separate issuance from the Office of the President, declaring all zero COVID-19 Provinces to be under General Community Quarantine (GCQ), to include the Municipality of Can-avid, Eastern Samar;

WHEREAS; that to be able to prevent the spread of this COVID-19 Pandemic to the Municipality of Can-avid, Eastern Samar, Front liners coming from **RHU personnel's, MDRRM- RESCUE team, Philippine National Police and Philippine Army, including Barangay Health Emergency Team (BHET)** as Multipliers, were assigned to deferent strategic locations or Checkpoints, within the entrance and exit route to this Municipality, with 24/7 duty;

WHEREAS; that there's a need to maintain food sustenance to all this Front liners for them to continuously exercise their duties and functions for the purpose of protecting our Municipality to be infected by this killer COVID-19 pandemic;

WHEREAS; that as provided for under the accounting rules and regulations, either the Local Chief Executive or the Municipal Treasurer is allowed by law to maintain Petty Cash just for the above-mentioned purposes;

WHEREAS; that in order to justify the use of Petty Cash as set-aside fund, taken from MDRRM trust fund, amounting to One Hundred Thousand (Php.100,000.00) Pesos intended for Food Consumption and sustenance of all Front liners. The Sangguniang come to approve to authorize **Municipal Treasurer Brenda P. Galupe** as Petty Cash Custodian solely for this fund. Subject to existing Accounting Rules and Regulations;

WHEREAS; Chapter 3, Article one, Section 444 (a) (1) par.vi of RA 7160 otherwise known as the Local Government Code of 1991 provides that *"Upon authorization by the Sangguniang Bayan, represents the Municipality in all its transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance"*

WHEREFORE, on motion of *Hon. SB Member GIL A. CEBRERO, JR,* Chairman, Committee on Disaster Management; duly seconded by *Hon. SB Member MILVEN C. COSO,* Chairman, Committee on Agriculture, be it-






